• The year is off to a good start and staff and students alike are settling in.

Fundraising Report

Shannon

- Deal Deck sales at learning conferences were successful; 89 decks were sold. Being able to see the decks before buying likely helped sales. Profit from the entire campaign is estimated to be nearly \$1500. One last reminder will be sent to families before sales close next week.
- Tracking of sales for prizes has not been done.
- The Admazing books produced better results, however, demand for coupon books in general seems to be decreasing.
- We have received \$1750 in donations from the Opt In campaign.
- A profit of approximately \$824 was earned from apple sales. Delivery of the orders takes place tomorrow in the gym. Pickup instructions have been set to parents. Unclaimed orders will be donated to the Food Bank.
- No volunteers have come forward to unload the delivery truck, however, most of the afternoon distribution shifts are filled.
- We are raising funds through Fun Lunch sales, but do not have an update on the amount earned thus far.
- Ideas for future fundraising campaigns include Purdy's, Blue Grass, greeting cards with artwork designed by our students, and pizza sales.
- NEE is running a Learn-a-thon this year. We will gather information from them to decide whether or not we want to do something similar.
- We must ensure to coordinate with SRC so that we are not competing with their initiative(s).
- Since we have raised approximately \$4000 so far this year, we will not run another fundraiser before Christmas.
- We will fund the purchase of Christmas cards (instead of birthday cards) for the staff.

Treasurer's Report

- Terry Fox Run day was good, albeit chilly.
- The staff had their own Welcome Back Breakfast coupled with a development day with SMS colleagues. One of the topics discussed was format changes to the Character Reports.
- Grade 8s viewed a film titled 2040 which is directed by an FFCA alumni. The film had a positive message about the world's future and was well received by students.
- Learning conferences went well. Thank you to Council for providing dinner for the staff.
- The staff room has been renovated and is now more comfortable to gather in as a large group.
- Randy Bottle, a local indigenous elder, will share his stories and virtual reality project with two classes.

- The Me to We club is travelling to Edmonton next week for an all-day event. Mr. Symonds will be accompanying the club.
- The TAAPCS (The Alberta Association of Public Charter Schools) conference will be held in Calgary next Friday and is a great opportunity for FFCA to interact and share information with other charter schools.

 - o Goal to increase parental involvement.
 - o Teacher appreciation dinner on the 10th and will be doing a taco bar.

- Bulletin board to highlight families that have reached their 20 hours.
 They also get a lunch with the principal and extended recess.
- There will be a gift certificate draw from In School Wear for those that have 20 volunteer hours.
- In lieu of starting now and then will have a learn-a-thon. They are raising funds for a hydration station.
