Chair Update

- Upcoming casino dates are set for Oct 22nd (Sunday) & Oct 23rd (Monday). Ummul noted
 that we will need to distribute a volunteer sign-up and we will need to be informing
 parents asap of the dates.
- Campus plans for student activities and asks were presented. They are as follows:
 - A big ask that is coming is to replace technology that is no longer working correctly and to bolster our technology supply with another laptop cart and between 30-40 chrome books.
 - Look at expanding support to fund some science-based lessons/guest speakers (field trips are funded a year in advance).
 - The third discussion point was on portables. All campuses had applied for portables and we were approved for same. The challenge is that there isn't a lot of portables available and we can't launch additional portables until they are all in place (due to the bubble of population that needs to move through campuses). The next ask is for school beautification as we may be able to do some pre-work for ground scaping that involves the portables. This is was a specific request that we decided needs to go to council.
- Obtained paperwork from casino advisors whom NMS has been using in the past and will get all the paperwork signed at the soonest.
- Scholarship application voting. Decision made to share our votes via email with the council. Only members of the executive are able to vote for the scholarships. Doug will forward the remaining scholarship that was not included in the email package. Action item: Doug has sent out the final scholarship. Please share your top choices.

Treasurer Update

- Update of signatures for members-delayed as Sanjib was away.
- We have a balance of \$29,237.87

- The money we currently have has to be used before we receive our next allotment. The full request for the chrome books would cost around \$40,000 so we can move through and purchase a number of the Chromebooks with the available funds.

- Action item: Ummul will be seeking out some documents that were used at a previous casino to support the process. This will be emailed out.

Administration Update

- Zenita asked if we would be able to bring back ski opportunities in the next year.
 Administration clarified that some of the events like skiing have become cost prohibitive, but they will be looked at again to see if things have changed. This includes swimming as well.
- A parent brought forward busing challenging. Jim noted that there's been some legislative changes and potential benefit packages that might help recruit more drivers. Many of the challenges are related to not having enough drivers. There was validation that the busing situations have been exceptionally challenging for families.
